Reasons for the vacancies:

The President was killed in an automobile accident (August 7, 2015)

The Parliamentarian had a disagreement with another member and said he resigned (I think August 6)

The two secretaries stop coming, but were not following protocol. (They were attending off and on) The president had me to send them a request to take the code of civility but they did not after being reminded. When DONE removed them from the board, one took it.

The At-Large member stopped coming, due to work or school don't remember which, supposed to start coming again.

From what I understand, Mr. Fuentes went on leave (got married) when he returned, he sent an email stating his resignation which I forward to DONE

July 24, 2015, I came from leave (I had a project to complete at schoolthree months), sent a letter about the challenges, accounts that had not been paid, grants that had not been processed and/or paid. I requested DONE to pay. Incorrect By-Laws were submitted, so I have been told.
