7. Committee Reports

a. Election and Outreach

Mrs. Jackson: The goals of this election are for every potential voter to be aware of the CANNDU election. There are a lot of people who are not aware of the elections. We want CANNDU to represent the community. We need a president, recording secretary; we have two member at large seats and a parliamentarian. There will be a meet and great on May 26 and it will in the library. We are also attempting another location closer to Slauson. Election is June 11th and we are planning to provide lunch for the first 500 voters.

Section Item b. Land Use

Lisa on Behalf of Verizon Wireless: We are attempting to put a new tower on the corner of Towne and Slauson. There is a gas company there and a bus depot. The bus depot is where we are putting the cell phone tower. The tower will be a 60 foot pine tree. Pine trees are very constructed; the antennas are very low visibility. Towers already installed are reaching their bandwidth caps. New antennas are to benefit people in the community. Tower placement is

becoming denser; People are using many more wireless devices. In the future it is predicted that there will be a cell tower every other block.

Ms. Simpson: Are there any health concerns placing towers in residential zones?

Lisa: We cannot discuss health issues legally, but we can discuss safety issues. The safety zone of an antenna is 12ft. We construct the tower to ensure that residents will not be within the 12 ft. zone. There is a public hearing on the 28th. We would like the support of the community. We are building cell tower in the region to help the community, to offer greater coverage.

Ms. Glaze: The board was supposed to write a letter to support or oppose the tower. We will open up the floor to hear comments from the community.

Ms. Campbell: I think the tower is a good idea. There are more people using cellphone towers and we need to increase coverage to prevent dropped calls.

Mr. Alvarenga: We need the towers more people are using cellphone towers and we need to create infrastructure to carry the calls.

Ms. Simpson: I agree with Mr. Alvarenga

Ms. Campbell: I wouldn't oppose it.

Mrs. Jackson: I want more information regarding the radiation. I want more information regarding the impact on people's health, especially pacemakers. I would be opposed to it.

Ms. Glaze: I understand that we need the extra coverage, but I do not feel comfortable approving it without having more information.

SH: I have a deep defibrillator and I cannot have a cellphone tower on my left side. This cellphone tower worries me.

Verizon Rep: If you are looking for an impartial view. You can look up information with the American Cancer Society. They are the experts on cancer and state that radio waves are not associated with cancer.

Section Item 6. Possible appointment of potential board member Juan Bustamante for Parliamentarian.

Ms. Glaze: Mr. Bustamante works for the 77th precinct he has volunteered to be the parliamentarian any questions before I vote?

Ms. Jackson: What are some of the issues that you think are problems here in the CANNDU region.

Mr. Bustamante: We have an issue with accountability. We need to focus more on community policing. Instead of stopping and asking what are you doing here? Ask how is your day going how can I help you? I want people's perception to change, instead of going out hunting. It is my belief that I want to help people and make myself available to protect and serve.
