B Neighborhood Council Sustainability Alliance Low Income Weatherization Program (LIWP) Laura Mack – Founding Executive Director

Emily Beierle O'Brien, Isai Reyes and John Shipman – (Neighborhood C.S.A.L.I.W.P.)

The Weatherization Program "getting the word out" is comprised of 25% dedicated to help low income population to reduce energy consumption, make environment healthier and more affordable. Program is free to anyone who qualifies; both homeowners and renters alike. Benefit: Indoor healthy air quality. LIWP is asking for help in promoting venture/program. This month 230 homes in LA County have been given this added value in single family, mobile homes and solar systems. Income maximum for one (1) person is \$50,500 – two (2) persons is \$57,700.
