Administrative Update:

The temporary services contracts for Neighborhood Councils have been finalized and are listed below in the Vendors section. The vendors can assist with completing Monthly Expenditure Reports for your Neighborhood Council, minutes, office work, etc. though not Neighborhood Council trainings. Funding Updates:

The Neighborhood Council Funding Program has completed the Budget Fiscal Year 2016-17 3rd Quarter replenishment. Funds up-to \$9,250.00 were deposited to the NCs' Union Bank Accounts. If NCs' Bank Accounts exceeded two quarters worth of allocations (\$18,500), excess funds will be placed in the NC's appropriation account. NCs may access their appropriation through a completed Cash Request Form.

The [Los Angeles City Council approved](#) an additional \$5,000.00 allocation for each certified Neighborhood Council. The prescribed method to access the \$5,000.00 will be available on February 1, 2017. There are six NCs with frozen funds for not submitting their Annual Budget. We look forward to celebrating the amazing accomplishments of Angelenos across our city whose efforts have made a direct impact in improving the quality of life in our neighborhoods.

Policy Updates:

Council File: 16-1456 relative to Limiting Access to Children's Playground was introduced on December 14, 2016 and referred to the Arts, Parks, and River Committee. In an attempt to provide for a safe environment in children's playgrounds, the City Council's Arts, Parks, and River Committee will be discussing a motion that is requesting an ordinance that limits access to a children's playground within a City park to children and parents or guardians accompanying a child. The motion is requesting that the Office of the City Attorney, with the assistance of the Department of Recreation and Parks, be requested to prepare and present a draft ordinance to the Arts, Parks, and River Committee on the proposed language. Additionally, upon approval of the new ordinance, the Department of Recreation and Parks is instructed to post signage at children's playgrounds. The motion is currently pending in committee and a hearing date has not been determined.

Update – Council File: 15-1022-S2 Motion relative to online voting and Improve Experience for Neighborhood Councils was scheduled for Council on December 2, 2016. The motion instructed the Department of Neighborhood Empowerment (DONE) to suspend the implementation of the online voting system for future elections until DONE completes a report with information about the experience of online voting for candidates, voters, staff and other stakeholders and on the actions that the Department intends to take to improve the implementation process. The Department is currently working on a report back to the City Council.

Update - Council File: 16-1324 Motion is no longer pending in the Rules, Elections, Intergovernmental Relations and Neighborhoods Committee. On November 30, 2016, motion was referred to Ad Hoc Committee on Immigrant Affairs.

This motion is relative to reaffirming support for Special Order 40. Since its issuance in 1979, Special Order 40 has defined the procedures followed by Los Angeles Police Department (LAPD) officers with regard to issues of immigration status. The underlying policy direction of Special Order 40 has been that a person's immigration status alone does not merit any police action. This policy has advanced the interests of public safety by allowing LAPD officers to provide law enforcement services equally to all residents of the City, including those whose immigration status may render them particularly vulnerable victimization.

Special Order 40 mandates that Police Officers not question individuals solely to determine their immigration status and ensuring that undocumented individuals residing in Los Angeles are able to report crime to the police and participate in investigations without fear of being deported. With the election of Donald J. Trump to the presidency, Immigrant communities fear mass deportations and other disruptive and damaging policies. The president-elect has taken an aggressive stance on immigration and because of this the Los Angeles City Council reaffirms support for LAPD's policies related to dealing with

undocumented immigrants, including Special Order 40, which ensures that all members of the community, regardless of immigration status, can interact with the Police Department without fear of being asked about their immigration status.

Update - Council File: 16-1331 relative to a possible May 2017 ballot measure regarding an all-civilian Board of Rights panel for disciplinary matters involving Los Angeles Police Department officers, was waived out of the Rules, Elections, Intergovernmental Relations and Neighborhoods Committee on December 6, 2016. City Clerk scheduled item for Council on December 13, 2016. An amending motion was introduced on the same day instructing the Chief Legislative Analyst (CLA), with the assistance of the City Attorney and the City Administrative Officer (CAO), to include in a report back an analysis of the application and selection process for civilian members of the LAPD Board of Rights. The motion also instructed the CLA to provide an analysis of cases, including rank of charged officer, and how Command Officers and Civilian Board of Rights members have ruled on matters, compared to the findings of the Chief of Police after the third year of the program if approved by the voters and implemented by the Council. City Council approved this item on December 15, 2016.

Update - Council File: 17-1100-S2 relative to Cannabis Related Activity was voted on by the City Council on November 15, 2016 to place the matter on the Ballot Measure on March 7, 2017. Hearings were held to hear community input under **Council File: 14-0366-S5** relative to Proposition D, Medical Marijuana Dispensaries and Adult Use of Medical Marijuana Act. The Rules, Elections, Intergovernmental Relations and Neighborhoods Committee held a hearing on November 29, 2016 and continued the item to **December 7, 2016**. At its special meeting on December 7, 2016, the Rules, Elections, Intergovernmental Relations, and Neighborhoods Committee, pursuant to Election Code Section 605, considered requests for designation as author of ballot arguments and rebuttal arguments in favor and against the ballot measure relative to cannabis regulation after citizen input, taxation, and enforcement;

No New Update - Council File: 06-0125-S2 relative to Nuisance Motels, Police Department Service Calls and Permit Feasibility Study is currently pending in the Public Safety Committee and a hearing date has not been determined. The City of Los Angeles is looking to explore the feasibility of a regulation program for nuisance motels that attract gang activity, drug use and prostitution. Such a program would have to be based on crime and calls-for-service statistics which would support the need to regulate motels. This motion is asking for a study to determine whether or not a police permit regulation is necessary to improve the safety issues at motels in the City. This is a citywide concern and necessary steps are needed in order to have an effective regulatory system in place.

If the Public Safety Committee approves this motion and any related reports (A **YES** vote) the matter will be scheduled to go before the City Council with the committees' recommendations.

If the Public Safety Committee does not approve this motion (A **NO** vote) the matter is still referred to the full City Council for deliberations, further instructions, or approval.
