Please note that Neighborhood Council boards may not give a Neighborhood Purposes Grant (NPG) to a non-profit school or an LAUSD school, where a board member's child attends. The entire board is precluded from hearing the matter. It is not sufficient for the board member with the child to simply recuse themselves from voting on the matter, the NPG will not be funded.

### ***Field Updates:***

Field is excited to release our new [Field service model](#), which is effective immediately. The Department is constantly finding ways to improve upon our service model to Neighborhood Councils. As a result, the Neighborhood Councils will be divided citywide under 3 Directors (Leyla Campos, Mike Fong and Stephen Box) with 2-3 Neighborhood Council Advocates to support the needs of their respective Neighborhood Councils. We will maintain the Neighborhood Council Support Helpline ([NCsupport@lacity.org](mailto:NCsupport@lacity.org) or 213-978-1551) as added ways to provide you with support, assistance, guidance and strategic advice Monday - Friday from 9 am to 4 pm. We will also be expanding our list of volunteer mentors under the Councils for Councils program to provide Neighborhood Councils with more assistance. Many of you have asked for the next Ethics and Open Government Training, and we are happy to announce a save the date for Monday, February 29th, in the San Fernando Valley (location TBD). Many thanks to all those who participated in the Homeless Count with the Los Angeles Homeless Services Authority (LAHSA). Your time, effort and dedication to your community are very much appreciated.

### ***Elections Updates:***

The Call for Candidates is underway and there are a dozen Independent Election Administrators who are eager to partner with Neighborhood Councils on Outreach strategies to engage stakeholders, including Digital Campaigns, Direct Mail Campaigns, Print Campaigns, Cable TV Campaigns, and good old-fashioned face-to-face campaigns. ### ***Policy Updates***

**Update - Council File: 15-1138 and sub council file #s #, 15-1138-S1, 15-1138-S2 and 15-1138-S3** relative to declaring a State of Emergency and providing emergency shelter and housing to the homeless were all approved by the City Council with an instruction for all report backs on the matter to go back to the City Council. A time frame was not given as to when the report backs will be available to the public. In addition to the report backs the City Council has instructed the City Attorney to report back with recommendation on matter. There hasn't been an update to these Council Files as the report backs are still pending.

**Update - Council File: 13-1493** relative to Street Vending was heard in the Economic Development Committee on October 27, 2015 and is now pending in the Public Works and Gang Reduction Committee. The City of Los Angeles is asking for a more comprehensive legal framework to effectively address sidewalk vending. The matter is now pending in the Public Works and Gang Reduction Committee and will likely be heard in Committee in February, but a date is not confirmed. If Public Works Committee's actions are different than Economic Development – a motion would have to be made in Council as to which report to adopt. The Public Works and Gang Reduction Committee has not set a date to hear the matter.

**Council File: 15-1007; 15-1002; 15-1004; 14-0057-S1; 15-1003; 15-1001; 15-1251; (HOUSE LA)** The Housing Committee approved a series of motions on Wednesday, January 20, 2016, that address the housing crisis in Los Angeles under the House LA Initiative. In an effort to cut red tape and streamline building in Los Angeles, Councilmember Cedillo will offer bureaucratic relief in order to facilitate smart growth. With approximately 25,000 homeless people sleeping on the street every night, the City of Los Angeles is faced with the task to build more housing and increase affordability. The Southern California Association of Governments' (SCAG) 2014-2021 Regional Housing Need Allocation Plan (RHNA) determines a need for 412,716 additional housing units in the 6-county region, with 82,002 of these units allocated to the City of Los Angeles. This need is divided among various income groups, including 20,427 for very-low income households, 12,435 for low-income households, and 13,728 for moderate-income households. This means a production rate of approximately 10,250 units/year (5,823 affordable/year). The House LA Initiative includes motions addressing; Expansion of Expedited Processing Section in Planning; Site Plan Review Modifications; Permitting Micro Unit Housing; Deferring Fees; Expanding the Use of Shared Vehicles; Facilitating Accessory Dwelling Units; and Using City Owned Land As Sites for Affordable Housing. All motions were referred to other City Council Committees pending report backs. Once the matter is scheduled for City Council, the elected body can vote to approve the matter, reject it, or refer the matter back to committee for further vetting or approve specific instructions as they see fit. The City Council vote takes

precedence over the committee's vote/recommendations. Has your Neighborhood Council submitted a Community Impact Statement (CIS) on the matter? If not, click [here](#) to log in to submit your CIS.
