Dear CANNDU Council leaders,

We have a lot of exciting stuff happening in March! Online Voting will launch this month in the Valley. Plus, EmpowerLA has partnered with Citywatch to launch a Neighborhood Council elections outreach page, which focuses on Neighborhood Council stories and why people should get involved in the Neighborhood Council system. On the policy front, Council President Herb Wesson has sent out a request to Neighborhood Councils to agendize and take action on the proposed DWP Reform Council File 16-0093 in March and April. There will also be special meetings on the reform, starting at Van Nuys City Hall on March 3rd. There's information on the DWP Reform under Policy below and how to take action to file a Community Impact Statement. Let's aim to have 96 Community Impact Statements filed on this Council File. Remember all CISs are listed by Neighborhood Council name and their position on the City Council agenda when the Council File is listed. It would be a transformational impact to have 96 Neighborhood Council names listed! Administrative Update:

Our Neighborhood Council Grievance Portal is now open to accept submissions. Please direct anyone who wishes to file a grievance with your Neighborhood Council to the portal for processing and review. Valid (grievances that can be reviewed by Neighborhood Councils and the Peer Grievance Panels) grievances will be directed back to the Neighborhood Council for resolution first. Funding Updates:

Funding Workshops have been scheduled for the following dates: March 21, 2016 from 6-9 at Fire Station 89, 7063 Laurel Cyn Blvd, North Hollywood, near Regions 1-4, and March 31, 2016 from 1 - 4 pm at EmpowerLA's downtown office. Funding Workshops have been scheduled through May 31, 2016. Please select your preferred date and RSVP here.

Treasurers may process payments for Election Expenses prior to full Neighborhood Council approval, provided the Neighborhood Council approved general categories for the election funding to be applied towards, such as mailers, flyers, advertisements, etc. Once paid, the Treasurer is required to submit the expense for final approval via the Monthly Expenditure Report. Department approval requirements remain the same, such as expenses greater than \$2,500.00 require Department approval prior to issuing payment.

We are still working with the Office of the City Attorney to find a method for Neighborhood Councils to provide Neighborhood Purposes Grants (NPG) to a non-profit school or an LAUSD school where a board member's child attends. Until then, the board may not provide such grants. It is not sufficient for the board member with the child to simply recuse themselves from voting on the matter.



Field Updates:

The Field will be assisting Neighborhood Councils in updating their Neighborhood Council inventory lists this month. Inventory includes office equipment, furniture, electronic equipment (computers, cameras, printers, etc.) and outreach materials (banners, signs, etc.). For purposes of this inventory survey, all Neighborhood Councils are being asked to report back on items that are currently in your possession and items that have been recently purchased. Please use the following Neighborhood Council Inventory instructions that will assist you in completing this requirement. You will be asked to upload your inventory information with pictures to a program we have developed.

Outreach Updates:

NationBuilder has "paused" all 96 Neighborhood Council accounts, restricting your ability to email those in your database, including county voter registration data and your organic data. The initial explanation was excessive spam reports and the Department is working on a resolution. The "pause" only applies to your ability to email from your account. It does not impact the other features.

We expect the accounts to be "unpaused" at any time which will give you the ability to email your organic data and those who have opted-in. We are still working to resolve the issue of emailing the county voter registration data.

In the meantime, you can conduct surveys, collect RSVPs, enlist volunteers, build petitions, host a suggestion box, and create event pages with invitations that can be shared via social media. You can even use it to build your website. You can also manage your social media strategy from your NationBuilder account, tracking activity and engaging the people in your database. For an additional fee, you can also set up texting and robocall features.

The Department apologizes for any inconvenience that the NationBuilder "pause" has caused to you and is working diligently to resolve the matter as soon as possible.

DWP Reform

Council File: 16-0093, introduced on January 22, 2016, relates to a proposed ballot measure to amend the Los Angeles City Charter and Administrative Code to restructure the governance of the Los Angeles Department of Water and Power (DWP). The Los Angeles City Council is assessing options to determine how to give DWP tools they need to be more transparent and more accountable to the public. This motion highlights various proposed charter amendments such as replacing the voluntary board with five to seven full-time, professional board members and removing requirements for City



Council approval or oversight of certain board actions. Furthermore, this council motion is instructing the City Attorney to work with the City Administrative Officer, to address the relevant Charter and Administrative Code provisions for the proposed amendments, and prepare additional language for necessary amendments to the Charter for inclusion in a 2016 ballot measure to be put before the voters of the City of Los Angeles. This motion has been scheduled to be heard in a Special Meeting of the Rules, Elections & Intergovernmental Relations Committee, on **Thursday, March 3, 2016, in Van Nuys City Hall at 9:00 a.m.**

This Council File requires major community input, and it's important that all Neighborhood Councils submit their Community Impact Statements and place this item on their agenda for discussion and action at their March and April meetings. This is a citywide issue that allows Neighborhood Councils to be engaged in the City's legislative process. There are plans to hold regional meetings throughout the City and partnering with the Neighborhood Council Alliances.

Motion to put on your Neighborhood Council agenda to take action on this item: "Discussion and possible action on City Council File 16-0093 to amend the Los Angeles City Charter and Administrative Code to restructure the governance of the Los Angeles Department of Water and Power (DWP). The board's decision will be submitted via a Community Impact Statement to the City Clerk to be placed on the City Council agenda for this Council File."

For your meeting discussion, here is some background and analysis:

Neighborhood Council-LADWP MOU Oversight Alliance Action - Additionally, the Alliance passed a motion at their February meeting, calling on the City Council to follow the recommendation of the charter mandated Industrial, Economic, and Administrative Survey to form "a committee to examine governance reforms for the Department with the explicit task of reporting its findings and recommending a measure for the 2017 ballot." Here is their motion:

"This Governance Committee should be involved in drafting any memorandums and other information from the beginning and include at least two members from the Neighborhood Councils who are familiar with the operations and finances of DWP.

The DWP Oversight Committee recommends that there be a transparent discussion and debate before any measure is placed on the ballot for voter approval or rejection."

Submit a Community Impact Statement (CIS) on the matter.
