Welcome to Fiscal Year 2016-2017! For new and continuing board members, thank you so much for your service to your neighborhoods and to the City of Los Angeles! We have an exciting year lined up with amazing workshops and new online apps to make your service easier. Please help us improve our Neighborhood Council support in all areas by attending one of our EmpowerLA Town Halls in July and August to give us feedback on what worked and what needs to work better for you. We are all about continuous improvement here so we appreciate all of your constructive comments. Check out the EmpowerLA Town Hall dates below! If you haven't already, please appoint your Neighborhood Council Budget Representatives because Budget Day is at the end of the month - July 30th. This is where the 36 Neighborhood Council Budget Advocates will be selected to work on the City budget this year and present their white paper in person to Mayor Garcetti and City Council. #### Administrative Update:

The contracts for the temporary services and training will be going to the Board of Neighborhood Commissioners meeting on July 5th for approval. If approved, it will head to the Mayor's Office for final sign-off.

#### Funding Updates:

The Funding Team is hard at work, reconciling the bank accounts in order to process your 1st replenishment for the new fiscal year. Please ensure that you have sent us screenshots of any outstanding payments by Friday, July 1st, close of business so that we can hold those funds in your account. Given the need to reconcile the accounts, and the upcoming holiday weekend, your first quarter replenishments should reflect in your checking accounts by July 11th or 12th. At long last, we are happy to inform you that a new **Neighborhood Council Funding Guide** has been developed and is ready for release. Please click here to see the new guide and let us know what you think! For those of you who have not yet begun, now is the time to discuss and approve your Fiscal Year 2016-17 <u>Budget Package</u>. #### Field Updates:

As the fiscal year comes to a close, Field Operations is happy to report that we have conducted board orientations across the City and have trained approximately 80% of the NC System on the basic board orientation. We continue to attend meetings to assist you in trouble shooting and continue to provide you with strategic advice and problem solving tips and tools to enhance and/or improve your daily operations. Our Help Line support continues as we have assigned one field staff member to respond to issues and monitor agendas and other correspondence coming in through NCSupport@lacity.org You might have noticed that there is more interaction and feedback from the Department's side regarding your agendas. Recently, we received feedback that we needed to clarify required language as it pertains to agendas you submit for review and posting to ENS. The required legal language on agendas is: 1) Title II ADA language, and 2) Brown Act language regarding public access of records. 3) An agenda item with the opportunity for general public comment. The rest of the static language that can be found on an agenda is recommended language as a best practice. Please note that the recommendations that we make to you about your agendas aim to provide more information in order



to address the public's questions or concerns thereby minimizing any interruptions, further inquiries and/or possible grievances that may arise out of lack of detail and information. If your agendas are missing any of the legal requirements, expect that staff will contact you for follow up on those issues. We thank you in advance for your partnership and flexibility in assisting us with the agenda posting task, by ensuring that all your agendas contain the legal requirements, correct dates and times for meeting, and are submitted in pdf format. Look forward to additional tools and training dates on agenda setting which we will be announcing in a near future. #### Elections Updates:

2016 Neighborhood Council Elections: Official Results

The results are in for the 2016 Neighborhood Council Elections! 25,571 voters voted for 1,839 candidates in 82 elections and 8 selections this year. The oldest candidate was 93 years old; the youngest just 14.

34 Neighborhood Councils helped pioneer online voting this year – a first for any election in the City of Los Angeles. 34% of those who voted in this year's Neighborhood Council Elections cast their ballots online, and half of those voters took advantage of the flexibility online voting offers, casting ballots either from their personal devices (34%) or at one of our 72 Pop-Up Polls (16%). The agility of online voting may be one reason why location and accessibility was one of the highest-rated aspects of the 2016 Elections, according to the 2,065 people who took our post-election survey.

The voting models this Election season were as varied as the 96 Neighborhood Councils themselves. There were 327 unique ballot types, and while many Councils used a single ballot, others used as many as 21 different ballots.

A BIG thank you to the Neighborhood Council leaders who worked with Independent Election Administrators, Election Managers, Election Assistants, Poll Managers, and Poll Workers to empower great candidates, engage passionate voters, and enlist enthusiastic volunteers. The Elections were successful because of the many people who pulled together to make the 2016 elections journey the best ever!

As your new Boards are convened and your Neighborhood Councils determine their vision for the coming years, please keep in mind the three key issues that surveyed voters felt affected their neighborhoods the most: Public Safety (16%); Planning and Development (15%) and Zoning and Land Use (12%). How can your Board best address the way these three issues impact your communities?

Finally, we hope you'll attend one of the town halls we're holding over the summer at locations throughout the City. We welcome your feedback on the 2016 Elections as well as any other comments you'd like to share that would help us better support our Board Members. #### **Outreach Updates:**

EmpowerLA's Outreach strategy for the 2016 Neighborhood Council Elections had 3 goals:

- 1) Increase awareness of the Neighborhood Council system
- 2) Encourage participation in Elections as a voter, candidate or volunteer
- 3) Facilitate voter registration

Nearly 400 street ads established a strong, Citywide physical presence across the domains of each of the 96 Neighborhood Councils. The bus benches; bus shelters; and pole banners promoted the message that "Neighborhood Councils Empower LA," and provided ways to learn more about the upcoming Elections.

A NationBuilder email campaign reached nearly 140,000 registered voters. Voters were introduced to their local Neighborhood Council, and given details regarding Neighborhood Council voting requirements; polling places; and voter registration links.

A Nextdoor messaging campaign reached over 148,000 opt-in residents. Nextdoor members were given information on how to register to vote, and where to vote - either online, or in person at the polls.

Successful, engaging Elections-specific assets were also created, including dedicated Elections social media accounts - which achieved a Klout score of 40 in just 40 days - and a weekly Election newsletter containing practical Elections advice, that maintained a 38% open rate and 20% click-through rate over 24 editions.

EmpowerLA's social media platforms have a combined Klout score of 62. An Elections promotional campaign that was at once broad and specific was mounted across all of EmpowerLA's social media outlets. Daily posts crafted to address specific Elections needs and concerns at the level of service regions or individual Neighborhood Councils were combined with systemwide advertising promoting the Elections as a whole, which resulted in nearly 138,000 individual impressions.

#### Liaisons:

Departmental Liaisons perform a key role in enhancing the government's ability to respond to your community's needs, as they serve as their Board's contact person for a particular City official's office; department; or even for other Neighborhood Councils. Agencies request Liaison contact info to share meeting or event invites; receive feedback; or request help sharing information with fellow Board Members or stakeholders.

Liaisons are often selected at the first regular meeting of a new Board. Two departments in particular - Animal Services and Public Works - have requested contact info for a liaison from each of the Neighborhood Councils, so we highly recommend that your Neighborhood Council at least assign a Board Member to each of these roles.

Another recommended assignment is your Department of City Planning Liaison, who will be the primary person receiving Planning Department packets for your Board to review. Since that person is receiving material in the mail that must be reviewed by your Land Use Committee, it's best to assign that role to a member of that Committee. (The Planning Liaison has a special sign-up process; see below for details.)

Assigning a Board Member to the Budget Advocates is also strongly suggested, as one of the most important opportunities Neighborhood Councils have to impact the City is the role they play in advising the Mayor and City Council on the City's proposed annual budget, and it is the Budget Advocates who do this work. The Advocates meet on the first Monday of each month; consult the EmpowerLA Calendar to see meeting times and locations. Assigning a couple members of your Board to attend the monthly meetings of the Citywide or regional Neighborhood Council alliances is also a good idea. There are alliances for each region; one for the entire City (LANCC); and a couple Citywide ones focusing on key topics like Planning and Land Use (PlanCheckNC) or Sustainability. There are also two DWP Committees for Neighborhood Council members - an Advocacy Committee that takes positions on water and power issues, and an MOU Oversight Committee that ensures the effectiveness of the NC/DWP MOU. Alliances allow you to gain support for an issue and learn key skills from other Neighborhood Council members. See the list of alliances and their meeting details here.

Other City agencies welcome having a point person on a Neighborhood Council, as well. Because of this, it's a good idea to agendize a discussion of which agencies are key to the needs of your Board and your community, and which Board Members you might assign to be the contact person for each agency your Neighborhood Council would like to foster a relationship with. (See a full list of City departments and bureaus <a href="here">here</a>.) Liaisons may then write to the department or agency they are assigned to to introduce themselves; give their contact info; and explain how their Neighborhood Council's interests or key issues intersect with the work that department does.

For Department of City Planning Liaisons, who will be the primary person to receive Planning packets for their Board to review, please <u>use this form instead</u>. Planning Liaisons must provide a mailing address that can securely receive oversize envelopes. Though your Board may choose to have Planning documents sent to your Council's general mailing address, it's a good idea to use a dedicated address for Planning materials that goes to someone on your Land Use Committee, so that there is no delay getting these time-sensitive mailings into the right hands.

#### Policy Updates:

**Update - Council File: 16-0093** relative to a ballot measure to amend the Los Angeles City Charter and Administrative Code to restructure the governance of the Los Angeles Department of Water and Power (DWP) was voted 15-0 by the City Council on June 7, 2016 to add the proposal to the November 2016 ballot. "Our objective was to make the DWP more efficient, and we think that we do that by giving a little more authority to the commissioners and the general manager to make more day-to-day decisions," said City Council President Herb Wesson. Council File: 16-0125-S2 relative to Nuisance Motels, Police Department Service Calls and Permit Feasibility Study was introduced on June 15, 2016 and referred to Public Safety Committee. The City of Los Angeles is looking to explore the feasibility of a regulation program for nuisance motels that attract gang activity, drug use and prostitution. Such a program would have to be based on crime and calls-for-service statistics which would support the need to regulate motels. This motion is asking for a study to determine whether or not a police permit regulation is necessary to improve the safety issues at motels in the City. This is a citywide concern and necessary steps are needed in order to have an effective regulatory system in place. The Los Angeles Police Department is being directed to provide relevant information on motels as it relates to the amount of calls they receive about problem motels, how many arrests and what kind of arrest take place on motel properties. The motion also calls for the Board of Police Commissioners, Commission Investigation Division to provide information on the feasibility and potential impacts of a policy permit on such business. In addition, the motion is also directing the Office of Finance to conduct and audit of the referenced motels to determine if they are current with the payment of their transient occupancy taxes as this may or may not be a result of nuisance activity. This study is important to the Los Angeles Police Department and to the Board of Police Commissioners to consider the use of a police permit regulation to address crime, gang activity, drug use and prostitution at nuisance motels. For these reasons, the City of Los Angeles is directing the Los Angeles Police Department, Board of Police Commissioners, and the Office of Finance to collaborate together to report to the Public Safety Committee the outcome of such study. A time frame was not given as to when the matter will be heard in committee or when the report backs will be available to the public.



If the Public Safety Committee approves this motion and any related reports (A YES vote) the matter will be scheduled to go before the City Council with the committees' recommendations to support the motion.

If the Public Safety Committee does not approve this motion (A NO vote) the matter is still referred to the full City Council for deliberations, further instructions, or approval.
