Happy Holidays! HUGE thanks to Board of Neighborhood Commissioners President Leonard Shaffer for the successful launch of the new Neighborhood Council Emergency Preparedness Alliance! There were nearly 70 attendees at the Emergency Management Department, and they were so enthusiastic about the need for Neighborhood Councils to be involved in a citywide response to emergencies that they'll be having another meeting this month on December 19th. Presidents and Chairs are encouraged to ensure that at least one person from their board or committee is attending this alliance meeting. Neighborhood Council elections are officially starting this month. The Online Voter Registration platform has launched and Regions 1 and 2 will open their candidate filing later this month. Lastly, please take a moment to review your board roster below to ensure that we have the correct information on members and their ethics/funding/code of conduct dates. Many board members are voting on funding items with expired ethics training, which will invalidate their votes. Any updates go to Rosters@EmpowerLA.org. Be safe and well this holiday season. ### Administrative Update:

Our online e-signature pilot is a success! We have completed the signing of several leases via email last month and will be expanding e-signatures to other legal and funding documents next year. Just a reminder that Neighborhood Councils cannot enter any legal contract without the review of the Office of the City Attorney and sign-off from EmpowerLA.

#### Funding Updates:

Funding Workshops have tentatively been scheduled for the following dates: December 9 from 1 - 3:30 pm, and December 17 from 6 - 9 pm at EmpowerLA's downtown office. Please RSVP by emailing the Funding team at <a href="mailto:EmpowerLA.Funding@lacity.org">EmpowerLA.Funding@lacity.org</a>.

Please work with the MER reconciliation team to ensure that your NC is current with submissions. If you are missing 2 or more MERs, you should have been notified by the Department and have until December 11, 2015 to submit any outstanding reports, otherwise access to your NC checking account will be frozen. The Third Quarter Replenishment is scheduled to be deposited into your NC's checking account by the first week of January, 2016. Based on funds available, your NC will receive up to \$11,250.00 by the end of that first week. Please make sure to always check your balance before issuing payments to ensure there are sufficient funds available to cover any expenses.

#### Field Updates:

As we approach the closing of the calendar year, we would like to remind you about the Homeless Count Memorandum of Understanding (MOU) with the Los Angeles Homeless Services Authority (LAHSA). As of now, we have only received a handful of NCs who have provided us minutes and/or a board resolution in order to initiate an MOU with LAHSA for the Homeless Count (see Council File 15-1356 below). Given our staff constraints, you may not always have staff at your meetings, but if there is a particular issue that you need help with, we can try to assist via the NC Support Helpline and with enough notice, send someone to your meeting. Thank you for consistently sending your agendas to NCSupport, we have received a total of 2,035 agendas for the first half of the fiscal year. We also have been working with City Attorney on a schedule for live Ethics trainings, and we'd like to begin in South LA. Please stay tuned as we provide dates for December and upcoming months in 2016 for Ethics trainings. The field division may also be undergoing some additional structure changes such as dividing the oversight of field operations into three areas and assigning a Senior Project Coordinator to oversee a small group of field personnel for those areas. Barring any unforeseen issues, we should have a new structure in place by start of the calendar year. We thank you for all your efforts, volunteer time and diligence in doing the work of your community, we know that you encounter challenges daily and we are constantly striving to improve upon the manner and strategies in which we provide support and assistance to you. We hope you have a safe and happy holiday season and we wish the best for our NC system in the upcoming year 2016!

#### Outreach Updates:

There are seven workshops in the first two weeks of December, focusing on Elections and Outreach, designed to equip Neighborhood Council leaders with all of the information that they need to conduct robust elections and to engage their communities with the latest in outreach strategies, including Social Media, Direct Mail, Public Events, Newsletters, NationBuilder and Nextdoor. #### **Elections Updates:**

There are 35 Neighborhood Councils that are participating in the 2016 Online Voting Pilot Project and the Voter Registration Portal is now live, allowing Neighborhood Councils to register voters so that they can voter from their desktop, laptop, tablet, or smartphone. In addition, 12 Neighborhood Councils will have telephone voting, allowing voters to use their cell-phone or touch-tone phone. #### Policy Updates

**Update** - <u>Council File: 15-1138</u> and sub council file #s #, <u>15-1138-S1</u>, <u>15-1138-S2</u> and <u>15-1138-S3</u> relative to declaring a State of Emergency and providing emergency shelter and housing to the homeless were all approved by the City Council with an instruction for all report backs on the matter to go back to the City Council. A time frame was not given as to when the report backs will be available to the public. In addition to the report backs, the City Council has instructed the City Attorney to report back with recommendation on matter.


