Dear CANNDU Council leaders,

We're happy to announce the City Clerk Neighborhood Council Funding Program will be reimbursing Neighborhood Councils for translation/interpretation costs. They will be using the \$60,000 in funds that was set aside by City Council under [Council File 17-0600-S41](#). For more information, please see the Funding section.

The City Council Budget & Finance Committee have started hearings to review the proposed Fiscal Year 2019-2020 budget. Under the City Charter, Neighborhood Councils have the ability to weigh in on the budget using [Council File 19-0600](#). Your Neighborhood Council can also submit a Community Impact Statement on the [Neighborhood Council Budget Advocates white paper](#) on the budget. The annual Neighborhood Council Budget Day is on Saturday, June 29, 2019 at City Hall. While registration is not open yet, we encourage you to save the date to come and learn about the City's budget process. Neighborhood Councils should appoint up to two Budget Representatives in time for Budget Day so that they can attend and represent the Neighborhood Council, but also vote for new Budget Advocates or possibly be elected themselves. On May 6, 2019, the Neighborhood Council Budget Advocates will be voting on whether to extend their terms again (they extended their terms for 1 year last year) for another year as well as keep the Budget Representative appointments ongoing until the Neighborhood Council replaces them. If this is passed, the current Budget Advocates' terms will end in May 2020, and the current Budget Representatives will continue to serve. Finally, just a reminder that for the 2019 NC Elections, the Department’s [board seating policy](#) shall remain the same as the past election cycles. The seating of a newly-elected Neighborhood Council board will take place when the City Clerk has issued certified election results for the Neighborhood Council; and all official election challenges for the Neighborhood Council has been resolved. The physical “seating” of the newly elected boardmembers at a NC meeting is only ceremonial. Our NEAs will work with the outgoing board to craft the agenda for the regular or special meeting to ensure a smooth transition between the outgoing and incoming boardmembers.

Funding

We are now in the 4th and last quarter of the Fiscal Year. Please keep an eye on the following deadlines impacting the Funding Program as we approach the end of the Fiscal Year:

- 1) May 20, 2019 - Final date to submit an event approval packet.
- 2) June 1, 2019 - Final date to submit a check payment request.
- 3) June 20, 2019 - Final date for any bank card transactions.

As previously mentioned, NCs have the ability to rollover funds at the end of the Fiscal Year. Please review updated Policies and Guidelines providing more details on the rollover, paying particular attention to the MER submission status. As NC election season is underway, please work with your DONE Field Representative to ensure a smooth transition of power from the outgoing Board to the newly-elected Board. With regards to accessing NC funds during the transition, please be aware of Board positions that are up for election or may be continuing as this may affect your Financial Officers, including Treasurers, Bank Cardholders, and Signers. Depending on your Board structure and election results, your NC may need to appoint new or re-appoint continuing Financial Officers at your very first meeting after the election. If necessary, our Office will work with you to process certain payments in a custodial manner, particularly office/operational expenditures as needed.

In addition to our regular in-person Funding Program and System portal training sessions scheduled at City Hall, we will be doing more training sessions throughout the City to accommodate new Financial Officers. The first couple of sessions will be for Central and East Area NCs whose elections are now certified. These sessions are also open to all board member and the general public. In case you are not aware, if your NC has service charges to be paid related to translation services, please submit the payment request through the Funding System portal. We will process the payment request using Special Account funds set aside by City Council under Council File 17-0600-S41. If you have any questions, please contact your Funding Program Representative.

Outreach

We are in Voter engagement phase of our outreach for NC Elections. Through social media, traditional media, and boots on the ground, we helped spread the word of deadlines to get out the vote. Valley and West Area elections will be in May. Our staff have mailed out letters and distributed flyers to Neighborhood Councils promoting elections. To encourage voters to vote, we are circling back with non-profits, schools, our media team has worked with elected officials and created "get out the vote" videos. South LA team will be conducting another candidate workshop to help train candidates on campaigning, asset mapping etc. The workshop is on May 11th at the St. John Well and Child St. Johns Well Child & Family Center

The Candidate Filing Period for the 2019 NC Elections has ended. A total of 1,804 candidates were certified to run for a NC board seat. Congratulations to all the candidates! Did you know?

Beginning May 1st, we will accept applications for bylaws amendments online until March 31, 2020. If your Neighborhood Council wants to make changes to bylaws, we recommend taking action as soon as possible to ensure the changes are submitted in time. The next bylaws amendments moratorium will be from April 1, 2020 to May 1, 2021.

Board Members with Expired or Missing Mandatory Trainings

To vote on Neighborhood Council funding items, Neighborhood Council board members must have current ethics training and funding training. The Neighborhood Council bylaws may also require these trainings to vote for nonfunding items as well. To serve on a board, Neighborhood Council board members must also have either read and signed a Code of Conduct or have watched the video. To complete these trainings, please click [here](#).

NOTE: in person and online ethics training must be a minimum of 2 hours. If you complete the ethics training online, please ensure that you take 2 hours to complete the training as we will not accept any certificates that show less than 2 hours.

Board Members who have not completed the Funding training:

Funding - Eligibility to Vote on Financial Matters a. To be eligible to vote on any NC Expenditure, Financial Reports, and/or annual budgets, the board member must:

- Be an Elected, Appointed and/or Selected Board Member of the NC
- Be 18 years of age or older
- Have completed the California State Ethics Training Requirement for Local Officials (AB 1234)
- Have completed the online NC Board Member Funding Training and obtain a passing score of 70% on any test associated with the online course.

Board Members with missing or expired Ethics Certificates:

ETHICS - All Board Members are bound by California State Law to take Ethics Training every two years. Take the online course, and send your certificate to Rosters@EmpowerLA.org. Ethics Training is a required for all Board Members
